ANNUAL CONGREGATIONAL MEETING MINUTES

Date of TUC Annual Congregational Meeting: February 26, 2012

1. Call to Order:

Reverend Bruce Kearley called the Annual Congregational Meeting to order at 12:10 pm on February 26, 2012, welcoming all those present.

3. Chair and Secretary for 2012 Congregational Meeting:

Valerie Howe nominated Bob Jenkins as Congregational Chair. There being no further nominations, Bob was declared to be the Chair.

Cle Callan nominated Gillian Corbett as Secretary. There being no further nominations, Gillian was declared to be the Secretary.

4. Acknowledgement and Thanks

Bob Jenkins expressed on behalf of the entire Congregation of Topsail United Church our deepest thanks to Rev. Kearley for his Ministry and work over the past year and noted how truly blessed we are to have him here with us at Topsail United. He also gave thanks to Valerie Howe, Board Chair for all her work and the Board also, for their contribution over the past year.

5. Approval of Agenda

The agenda was approved. The Chair noted that all reports would be presented and discussed except for that of the Finance Committee then there would be one motion to accept them all.

The Financial reports including the 2011 Budget would be approved in separate motions.

It was noted that for the Annual Report 2012, as a paid employee, Youth Band Leader Brett Vey should be included with the staff listed at the top of the page.

Rev. Kearley drew attention to his letter, highlighting the “journey” and our discipleship. He thanked the congregation for their help throughout the year and lifted up the pastoral needs of the congregation to maintain the presence of the church in the community. The Pastoral Charge is large and the immediate needs many, making routine pastoral visiting difficult. He hoped that a Lay Visitation program might be implemented in 2012.

Rev. Kearley made approximately 490 pastoral contacts over the year.

Rev. Kearley welcomed the addition of Christian Coordinator, Steven Rogers adding that one of the duties of this position is to reach out to new families.

Rev. Kearley also spoke of his service to the wider church community and as a Canadian Forces Chaplain. He sits on the Conference Book Store Committee and the District Education and Students Committee.

He concluded by saying that the year ahead would be challenging as we celebrate our 175th Anniversary and he thanked the Board, especially those who were leaving this year, the staff and Dianne for their continued support.

FROM THE MINISTER'S DESK

Dear Friends:

Greetings in Christ's name. 2012 was a very busy year at Topsail United (*The Church by the Side of the Road*) as we celebrated our 175th Anniversary. The theme for the year was **"A Time to Rejoice"** based on the well-known and well-loved passage of Scripture recorded in Ecclesiastes 3. The passage assures us that God is with us in all of life's journeys. The activities of our 175th Anniversary gave us the opportunity to celebrate past and present blessings of our faith and look, with joyful anticipation, to our future journey of work and witness as people of God. The activities included an old fashioned concert, a tree planting, dinner theater, participation in worship by former clergy and those who have entered ministry from our congregation, Sunday School picnic, a special Anniversary banquet and a booklet, researched and written by Dr. Sharon Deemer, depicting the history and current ministry of our church. All of these activities culminated with a special Anniversary service on November 18th.

The Anniversary service was indeed a very uplifting experience and was, for our congregation, **"A Time to Rejoice"** as all of our choirs and special guests led us in special music, song and reflection. Special guests at the service were the Lieutenant Governor of Newfoundland and Labrador, The Honourable John C. Crosbie and his wife Jane Furneaux Crosbie. Mr. & Mrs. Crosbie enjoyed being with us and the Lieutenant Governor made special mention of the service in his annual New Year's address to the province with the following words: *"...participated in an outstanding church service at the 175th Anniversary of the Topsail United Church on November 18th, when an outstanding service was performed by several choirs, ministers and people generally – an uplifting experience!"*

The Anniversary celebrations were a wonderful part of our church's life and work during 2012. I want to thank the congregation for your support of this event and a special and big thank you to the Anniversary Committee (*Chair: Eileen Green and Members: Bonnie Robbins, Lorraine Jarvis, Margaret Clouter, Rosalind Foley, Bob Bennett and Larry Grandy*) whose commitment and hard work enabled every activity to be a special memory. Our celebrations gave us the opportunity to reflect upon the fact that God is a **God of every song, every story, God of every captive set free, God of every dance, every footstep, You bring joy to me.** ("More Voices" #40 – "Never Ending Joy")

Our Congregation in 2012 welcomed Mr. Steven Rogers in the position of "Congregational Designated Minister". Steven is directing our Christian Development ministry and, along with the dedicated work of our lay people involved in Christian Development, has developed new programs for Sunday School and continued to build and enhance our youth

music program and has recently started a Rhythm Band, in addition to our Children's choir, youth choir and youth band to lead in Sunday worship and on other occasions throughout the year. We are very glad to have Steven with us and are truly blessed and inspired by his ministry.

The Annual Report gives an account of the life and work of our congregation for 2012 reflecting God's love and guidance in our witness. It is with praise to God and a thanksgiving to you, the members of this congregation, that this report is compiled and made available. The method by which you can maintain regular contributions is by using weekly envelopes, monthly envelopes or by contributing through PAR (pre authorized remittance). Our church office can give you information on any of these alternatives. Thank you for your generous financial support.

I also, on behalf of myself and the congregation, want to express deep appreciation to our other church staff. Thank you to *Lynn Mercer, Roger Richards, Nadine Hollett, Andrea Deacy, Brett Vey, Rosemary Richards* and, *Steven Rogers* for their support, expertise, help and guidance to me and our congregation.

We recently were introduced to a new song in worship entitled: *"Over My Head" ("More Voices" # 88)*. The song assures us that, as we face the realities of daily living with its celebrations and struggles that God is there. He, together with our competent staff members ensure that the church runs smoothly from worship, to the programs, the administration and the upkeep of the building. Greetings!

I write this letter with a deep sense of gratitude for the many blessings that have been bestowed upon Topsail United Church. This past year has been a time of challenge and celebration. We celebrated the 175th anniversary of our congregation and we explored new opportunities. I was glad to be part of this journey with you.

In January 2012, I joined Topsail United Church as your new Congregational Designated Minister with responsibilities in Christian development, youth ministry, outreach and education. Throughout the year, we were blessed with many talented and dedicated individuals who volunteered much time and effort to these ministries. Together we initiated considerable change and experienced growth.

In the winter, the Youth Group engaged in a series entitled “The Hunger Games and the Gospel” that focused on the themes of justice and power as found in the Bible and the Hunger Games Trilogy. In the fall, we explored global issues such as immigration, pandemic diseases and saw how some teens have advocated on these issues with reference to the parable of the Good Samaritan. The Children’s Choir and Youth Band provided beautiful music to our Family Services that were held on the 3rd Sunday of each month. The Men’s Club donated a new drum set and percussion instruments to the Youth Band and these are greatly appreciated. A new Rhythm Band was formed in the fall to allow opportunities for boys and girls to learn performance skills in hand drumming and other musical techniques that are beneficial in our worship services. These hand drums were also donated by the Men’s Club. We were fortunate to have both laity and clergy to lead the meetings of our Adult Study Group in both the winter and autumn seasons. You will find details regarding the Sunday School in a separate report. These programs have a very positive impact on our congregation and community.

I would like to thank Rev. Bruce for his support and encouragement throughout the year. He is a real benefit to the United Church and it is a joy to be in team ministry with him. I also send a big thank you to the staff, committee members, board members, and congregation members for all the work and contributions you’ve made this past year. Welcome to all who have found a church home here at “The Church by the Side of the Road” over the past year and thank you those who continue to support our church community.

Historic Roll: This Roll contains the names of all those who have joined Topsail United by confirming their baptismal vows, or by profession of their faith or by the transferring in of their membership. The Roll should only contain the names of those members who **reside in the area and who continue to have an active interest in the life and work of the church.** Membership is subject to review by the Official Board. In 2012, **5** new members were added by Confirmation, **14** new members were added by transfer and **2** members were removed by their death. The Historic Roll currently lists **503** members. Please call the Church Office if you need information about Transferring your Membership or wish to confirm your baptismal vows.

Invitations to come to Sunday School were sent to 27 children living in the Pastoral Charge who were baptized here and started kindergarten in September. Our church records for 2012 list **46 Baptisms**, **13 Marriages** and **17 Funerals** conducted at Topsail United Church throughout the year.

Supporting Families List: A new Membership Information Form was distributed with the 2012 financial reports. We would appreciate the return of these forms so we may update our information. In 2012 there were **335** listed families financially supporting the church and a further **103** families listed under our Pastoral Care.

Newsletter: All those on our Supporting Families list receive the Newsletter, which was published in the Spring and Fall. 149 people are now receiving their Newsletter by email.

Neighbourhood Contacts: We could not possibly get our Newsletters out without the help of this dedicated group of 28 volunteers. Many thanks to all of you who have delivered the Newsletters this year.

“Meet and Greet”: The Committee continues to sponsor “Meet and Greet” each Sunday following worship (except for Family Worship, which is sponsored by Outreach). This social gathering provides the chance to meet new people and have a chat. We encourage everyone to attend.

Pastoral Care Team: Discussion is ongoing on the viability of training volunteers for visiting our seniors who can no longer get out to church, but would appreciate such a visit in addition to their visit from Rev. Bruce.

Summary of Activities:

Worship and Sacraments met on four occasions during the past year. The Sunday worship schedule for the year was established and business related to worship in the sanctuary was conducted.

During the absence of Rev. Bruce, worship was conducted by clergy from our congregation, Rev. Harry Whitehorne, Rev. Bill Williams and Ms. Lorraine Jarvis. We are extremely grateful to each of them for their willingness to serve. During the past year Rev. Harry moved to the West Coast and took up an interim position in Corner Brook. We miss him and wish him well.

Together with our Sunday services, our congregation worshipped together on the "Longest Night" with harpist, Ed Kavanagh; Rev. Bruce and Emily and Ashley Howe providing the music.

This was a year of celebration as we at "The Church by the Side of the Road", celebrated our 175th Anniversary. We began by hanging a beautiful banner in the sanctuary reminding us that this was "*A time to rejoice*". In January, there was a concert with our choirs, band, UCW and others of our congregation coming together to remember and celebrate. One Sunday of each month, former clergy of our church brought the message as we worshipped together. One of the highlights of the year was our Anniversary service in November with all choirs uniting to sing in praise and thanksgiving for 175 wonderful years as Topsail United Church. The service was beautiful with The Lieutenant Governor, Mr. John Crosbie and his wife, Ms. Jane Furneaux-Crosbie among our many guests. His honour so enjoyed the service that he mentioned it in his year end address to the province.

Our Children and Youth Choir and Band held a concert fundraiser in support of our music program early in the year that was well attended and enjoyed by our congregation and others. Linnea Good held a workshop for all interested members of our congregation, with a special emphasis on music and worship. OUTREACH COMMITTEE FOOD BANK REPORT

Thank you for your support of the CBS/Paradise Community Food Bank through donations of both food and money during 2012. Please remember the first Sunday of each month is highlighted for donating to the Food Bank and you will find a list of items in short supply printed in the Bulletin. Thank you to the Men's Club for their additional donations of food throughout the year.

The Food Bank continues to be well supported by the community at large and again there was a tremendous response to the Christmas Hamper program, which was changed to monetary donations in 2010 is working really well. Our congregation donated monies in excess of the requested 40 Hampers. A total of 240 Christmas Hampers were prepared. Some of our regular clients were looked after by other organizations such as "Single Parents" for their Christmas Hamper. All Christmas Hamper, as well as regular hamper requests, are filed with "Food Sharing" to eliminate duplications.

The majority of monthly Hampers are requested by people who are in receipt of government assistance. We know that there are others in need especially the working poor and those waiting to receive benefits. If you know of someone who is in need please let them know that the Food Bank is there for them. **No one is turned away.**

The Food Bank has been seeing a steady increase in regular clients again during 2012.

The Food Bank continues to supply lunch items, on request by schools in the CBS/Paradise area, to be given out as needed.

At the end of October the Food Bank was advised that it would have to move from the premises in Chamberlains. It is now located behind the Mary Brown's in Manuels. Rent and services have increased threefold which is putting added pressure on the financial situation. The Food Bank Board must deal with this in 2013 and we may be asked to contribute more money on a regular basis.

The Annual General Meeting of the Food Bank is held each May and is open to the general public.

PROPERTY AND TRUSTEE COMMITTEE REPORT

Summary of Activities:

As indicated in last year's annual report, a main focus of the Property and Trustee Committee in 2012 would be to tackle the problem of persistent leaks in the building. To achieve this we first of all dealt with the problem in the church hall and, under the supervision of Freeman Budgell, a contract was let to repair cracks in the concrete wall, which to date seems to have solved the problem. The second major problem was the leaks occurring through the roof. It was determined that piecemeal efforts would not be successful in solving this problem so the Board decided to completely reshingle the building. Through the initiative of Paul Burt we obtained a very favourable contract and the work was completed in a timely fashion.

A second priority for the past year was to make some improvements to the washroom and nursery area. To this end we spent considerable time during the spring and summer consulting with an architect. We received a report that covered extensive renovations as well as upgrades to the hall that he felt were necessary. The quoted cost, however, was felt to be excessive and no action was taken on the recommended alterations. Our washroom area, therefore, continues to be a concern and one that should remain a priority for the coming year.

Other projects that members of our Committee assisted with during the year include

- The provision of office space for our Christian Development Coordinator. For that we are appreciative of the efforts of Freeman Budgell.
- Moving the sound board to the back of the church. The woodwork involved in this project is a testament to the talent of Lloyd Johnson and Roland Regular.
- Providing the means of safer access to the steeple from the vestibule. Again we are indebted to Freeman Budgell for his efforts in this regard.

In its role as the Cemetery Committee of our church the Property and Trustee Committee again put in place a summer maintenance program for our three cemeteries. In addition, at Upper Gullies the parking area in front was extended and all the painting was completed; in Long Pond the necessary repairs to the fencing were made; and in Topsail we applied for and received a Town Heritage Grant to replace the gate which will be in place in the spring.

Many thanks are extended to all Committee members for your continued support and willingness to contribute whenever called upon.

Let us rejoice! It's hard to believe that the year has come and gone and is now behind us marking another special event in the life of Topsail United Church. It was a time of celebration and serious reflection and also a time to look to the future with renewed vision, hope, confidence and commitment.

Our logo for the year was ***"A Time to Rejoice"*** (Eccl: 3 – 4).

The celebrations for the year went smoothly and the Committee is very pleased with the overall celebrations for the year. From a financial perspective, total income from Anniversary events totaled \$15888.75. Total expenses related to the Anniversary year totaled \$12,168.94. The balance remaining was \$3,719.82. Please note that Anniversary Booklets are still available at a cost of \$6.00.

Highlights from the 175th Anniversary celebrations include:

- Invitations to eight former clergy, Rev. Pearce Penney, Rev. Lorraine Jarvis, Rev. Myles Vardy, Rev. Jack Mercer, Rev. Mel Ralph, Rev. Scott Parsons, Rev. Harry Whitehorne and Rev. Ralph Taylor who participated in different Sunday services throughout the year.
- The year began with an Old Fashioned Bean Supper and Variety Concert which was a huge success. Special thanks to the Men's and Ladies Groups for putting this together for us.
- At our first anniversary Sunday service in January we unveiled a beautiful banner which was designed by the committee and printed for us by Stagg Signs in Grand Falls. The banner hung in the sanctuary during the year reminding us of the 175 years of history at Topsail United Church. A special thanks to Richard Sparkes for his photography work on this banner.
- Lapel Pins were designed by the Committee and they made a very nice souvenir item for purchase during the year. This was a successful project.
- Bookmarks were designed by the committee and given to people as a souvenir item of the year.
- The Dinner Theatre by Spirit of Newfoundland in June was a sold out event. It was a fantastic evening at the Masonic Temple in St. John's.
- The Church/Sunday School picnic in June had a small turnout but those present enjoyed the gathering and the entertainment by Terry Reilly. This was held at Topsail Elementary School grounds.
- During the month of May a beautiful Spruce Tree was planted in front of the church as a permanent marker for this year. It is very healthy and weathered Tropical Storm Leslie very well. A plaque has been affixed to the area giving details regarding the planting.

- A Commemorative Book went on sale in November at a cost of \$6.00. Sales have been lower than expected but we will continue to have these books available in the front vestibule on a regular basis. Special thanks to Sharon Deemer the excellent job she did compiling this historical book for us.
- The final event of our year was the Anniversary Banquet on November 17th which was held at the Royal Canadian Legion in Kelligrews. Numbers were lower than expected with 124 in attendance. A special note of thanks has been sent to Max Robbins for the great job that he did as Master of Ceremonies for the evening.
- The conclusion to our exciting year was on Sunday, November 18th with Rev. Ralph Taylor as our guest clergy. Special guests at this time were His Honour Lt. Governor John Crosbie and Her Honour Jane Furneaux-Crosbie. All choirs participated in this service and as one visitor remarked "It was an awesome choir presentation for such a small church." Personally I was very moved by the music on this Sunday. The work that went into this service was very evident and all choir members are to be commended for their efforts. Without an Organist and Choir Director(s), this could not have happened, so, on behalf of the Anniversary Committee I personally would like to offer our gratitude for your leadership during our closing service of the anniversary year. Highlights – 2012

- Surplus of \$35,120 compared to a Budgeted Deficit of \$13,916, primarily due to/despite the following:
 - Congregational givings (all categories) over Budget by nearly \$14,000
 - Special Bequest of \$48,680
 - Extraordinary repairs to the roof of \$23,625
- Without the Special Bequest and the expense of roof repairs, would still have generated a Surplus of around \$10,000
- Combined surplus for 2012 and 2011 nearly \$63,000!
- 175th Anniversary Celebrations resulted in net revenue of around \$3,700
- Organ Loan paid off February, 2012
- Steeple loan balance = \$5,600 at December 31. Payments are \$1,667 per calendar quarter. To be paid in full July, 2013
- Bank account balance at year-end = \$112,924
- 109 families on PAR

Budget Submission – 2013

- Budgeted increase in revenue of approximately 3% over regular non-recurring 2012 revenue
- Budgeted Deficit of \$9,479 primarily due to provision for Capital Expenditures by Property and Trustee of \$10,000
- Accumulated surpluses allow this year's Budgeted Deficit to be absorbed without impacting upon the current financial position
